sentence under the United States Sentencing Guidelines imposed following her guilty plea
to unarmed bank robbery in violation of 18 U.S.C. Secs. 2113(a) and 2. Bleich's counsel
submitted a brief in accordance with *Anders v. California*, 386 U.S. 738 (1967), in which

he identifies four possible issues but finds no merit in any of them. We have reviewed the entire record including the transcripts of the sentencing and the Fed.R.Crim.P. 11 hearing and conclude that Bleich's guilty plea was voluntary and intelligent and that the district court did not err in imposing the sentence. 3 The only remaining issue which we can discern is whether the United States Attorney's sentencing memorandum and arguments at sentencing conflicted with the plea agreement. The record is clear that the memorandum and arguments were not intended to and did not conflict with the plea agreement. The district court took into consideration the factors in 18 U.S.C. Sec. 3553 in imposing the sentence and stated that "the matters set forth in the Government's sentencing memorandum have been considered in arriving at the sentence." The memorandum itself described in detail the evidence which led to the armed robbery charge as was contemplated by the plea agreement. In short, there was no conflict. 4 AFFIRMED. * The panel unanimously finds this case suitable for decision without oral argument. Fed.R.App.P. 34(a); 9th Cir.R. 34-4
